

Are you in alignment with the Reformation of The Constitutional Reformation Of Australia??

Here is a logically sequenced brief summary based on some key points:

1. The Current Government Structure and Its Issues

- **Corporate Control:** The Australian government is a Corporation separate to the Commonwealth Government described in the Commonwealth of Australia Constitution Act 1900 UK. - **Under section 42 of the Constitution** anyone who has not sworn the Oath or Affirmation that is prescribed in the schedule is forbidden to take their seat and can't participate in the Parliamentary process.
- **Australian Electoral Commission** in 1973 the Whitlam Government unlawfully removed the term Commonwealth from all aspects of all government departments including the Commonwealth Electoral Commission and replaced it with the Corporate, Australian Electoral Commission, what this means is when you vote you are voting outside the Constitution to agree to the terms and conditions of the Corporate Commonwealth for the next 4 years.
- **Today in Australia** there are 2 Commonwealths there is a Corporate Commonwealth and a Non corporate Commonwealth which is the Commonwealth, the Corporate Commonwealth is separate by law to the non-corporate Commonwealth, .
- **State & Federal** The Corporate Commonwealth that is separate by law to the Commonwealth includes but not limited too, The Parliament Of Australia, The Australian Electoral Office, The High Court of Australia, The Australian Federal Police as well as all State and territory governments and includes every agency including police, Courts and the LGA and local governments.

2. The Need for Constitutional Restoration

- **Restoring the 1900 Commonwealth Constitution:** The central goal is to restore the original 1900UK Commonwealth Constitution non copyright version, which is

the rightful legal framework for the country. The constitution is essential to bringing Australia back under lawful governance. Without a Lawful Constitutional government all that left is an open pathway to wholesale corruption and the destruction of individual rights and freedoms leaving the Australian people no better off than the people in Communist China, this must not be allowed to happen

- **Surveillance & Restriction:** The electronic and digital tracking of the Australian people will stop, the collection of data of non-criminal activity will be forbidden by law, no vehicle will be permitted for sale in Australia that has Geo Fencing ability, all data collection by corporations will be prohibited from sale.

3. Vision for Governance Reform

- **Direct Constitutional Democracy Through Blockchain:** A proposal for a new, transparent form of democracy, utilizing blockchain technology to run regional and National referendums. This would allow the people to directly vote on important national and regional decisions, giving people more control over their governance. This would also speed up the wheels of government and also allow for poor performing officials to be replaced without the massive expense as is currently the way
- **Flat Tax System:** A new tax structure is proposed, introducing a 5% flat tax rate. This would replace the existing system of multiple taxes (GST, wage tax, company tax, etc.) This method of Tax would increase the Government revenue to in excess of 2 Trillion dollars of today's money. The entire ATO would be dismantled as there would be no requirement for them. There would be introduced a New bank Of Australia will be created to accept all Tax input, this will simplify the financial system for the people and businesses. This institution would also be responsible for holding Australia's Gold Reserve, not the UK.
- **Return of National Assets:** The Reformation movement calls for Australian infrastructure, such as energy and resources, to be owned and managed by the Australian people rather than foreign corporations or interests.
- **All Contracts** created by the Corporate Government since 1973 must be reconsidered and if necessary re written or simply stated as unlawful as the contracting body had no actual authority to commit any aspect of Australia's resource.
- **Currency Backed by National Resources:** A proposal to introduce a new currency backed by Australia's natural resources (gold, silver, uranium, Iron ore, coal, gas, oil, copper plus the average of the past 10 years agriculture recites etc.), with the goal of making Australia's currency one of the strongest globally.

- **Strength** this will strengthen the individual men and women's personal assets as their labour would be rewarded with substance of realised value, this method of currency would be called the Commonwealth Of Australia Decimal Pound.
